University High School is a small, one-school LEA and thus, operates as its own District. Administrators have many roles, including Special Education administration and District administration. UHS Administration sought feedback from its faculty, parent group (Phoenix Alliance), School Board, and also posted a draft on our website. UHS does not have a local bargaining unit or separate parent groups, such as Tribal groups or Civil Rights Organizations due to our small student population size. All parents meet together through the Phoenix Alliance group. The UHS Principal sends out a weekly email to parents and includes information that can be found on the website. Thus, all parents, including parents of English Learners, parents of Special Education students, and parents of all particular groups have been notified. Feedback sent in to administration include numerous comments and commendations in favor of building a structure on campus. Due to Covid, UHS students desperately need a place to eat lunch, and UHS also needs an outside classroom space. UHS engaged in meaningful verbal consultation with their community partners via Phoenix Alliance meetings in August and September, 2021. Students were presented this plan at an ASB meeting in the Fall semester, 2021. Students asked questions and gave feedback. This ESSER III plan was adopted by the UHS School Board on September 2, 2021.

A description of how the development of the plan was influenced by community input.

Due to the COVID-19 pandemic, it was very apparent that UHS students do not have a proper place to eat lunch. While there are some covered tables on the east side of the campus, and there are some shaded areas on campus, an additional shaded structure with electrical outlets and a fan is desperately needed for students. Pre-COVID, students ate in classrooms and on the Fresno State campus. Students are not allowed to eat lunch in classrooms any longer and only vaccinated students are allowed to go onto the Fresno State campus. That has left a large number of students on campus looking for a place to eat lunch. When this idea was presented to the UHS community, support was given and agreed upon for the a large portion of this money to be used for this structure. Community members felt it is very important to add this structure so that students have a shaded place to eat lunch and the school has a new area outside in which to use for classroom space, club meetings, music practice, etc.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
