Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The University High School administrative team met numerous times to discuss the grant requirements and identified the students in need. At every Faculty Meeting beginning in March, the staff offered input, dialogue, ideas, and suggestions. At monthly Phoenix Alliance meetings beginning in April, the principal will share the information with parents and attendees. The principal also sends out a weekly email and a monthly newsletter and will describe the summer school programs in greater detail.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified for extra learning activities by reviewing grade reports, counselor recommendation, and self selection. Current work is underway to identify the immediate needs of students and determine which subjects can be reviewed and remediated during our Spring Intersession. In doing so, some students can review math during the two week elective intersession and then are properly prepared to retake Physics or Chemistry and be more successful. Counselors, administration, parents, and students will work

together to prepare the best plan for the student in order to ensure the student's success. Students' social-emotional needs will also be monitored in order to offer students classes or programs that will help them to improve their mental health.

University High School has not offered summer school in previous years. Due to the learning loss experienced by students and to promote this new initiative, Individual meetings with the student and parent, along with the counselor or vice principal, will be organized to promote understanding and success for the students that need summer school. Additionally, the principal sends out weekly emails and a monthly newsletter and will outline the summer school program in both informational formats. The school bulletin will also include information on how to sign up for summer school and a list of available courses.

A description of the LEA's plan to provide supplemental instruction and support.

University High School has 3 plans for supplemental instruction and support. They are:

1) Summer School (credit recovery): Students that are deficient in credits will meet with a UHS fully credentialed teacher using the Edgenuity program to remediate the necessary subject.

2) Summer School (supplemental session): Students will sign up from a menu of classes offered to provide enrichment and additional instruction. Class ideas include Microscope Training and Skills Development, Creative Writing, and Writing and Giving Speeches.

3) Incoming Freshmen Boot Camp: Knowing that students choose to attend University High School from about 40 different zip codes around the San Joaquin Valley, we have to not only create a culture specific to UHS, but also bring students up to grade level standards since UHS is a high performing high school with dual enrollment classes for 10-12th grades. We plan to create a week long boot camp that introduces admitted students to the subjects that they will have at UHS in the 9th grade, many of them new subjects (Latin, Musicianship) and also begin to create a culture of teamwork, study skills, and camaraderie.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

University High will use the Expanded Learning Opportunities grant in congruence with the In-Person Instruction grant, ESSER II and ESSER III grants funds to maximize support for all students. The supplementary grant funds allow UHS to buy additional PPE for students, teachers, and staff, cleaning and disinfecting supplies, air purifiers and hand sanitizer dispensers for all classrooms, and possibly even an outside structure for students to eat lunch underneath. The ELO grant provides for the people and programs, and the other grants provide for the supplies, materials, and equipment needed to safely and effectively provide instruction.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
